In Kazakhstan, the share of online retail from the entire retail is about 1-1.5%, but everv vear the e-commerce market grows bv 30-35%. According to Satu.kz, the leader of online commerce in Kazakhstan, in 2017, Kazakhstan bought goods for 20.144 billion tenge on the marketplace. The average check for one online purchase grew by 19% and amounted to 34,742 tenge.




Fig. 1. Represents commodity circulation In Kazakhstan for 2018

The tax regime based on a simplified declaration, or simply simplified, is considered the most convenient mode for entrepreneurs due to the easy procedure for submitting tax reports, which can be managed by any individual

entrepreneur or LLP owner without an accountant's help, as well as low taxation. Only 3% income tax.

Kazakhstan Internet sellers exempt from taxes

Internet sellers in Kazakhstan were exempted from taxes for five years. In accordance with Article 293 of the Code ratepayer that sells item online will not pay corporate income tax that calculated according to article 302 of the Code. Also, according to clause 2 of Article 636 of the Code, Internet sellers who operate as individual entrepreneurs are exempted from taxes under certain conditions.

LLP taxes

Each owner of the LLP must pay at the end of the reporting period: Corporate income tax (CIT) is 20% of the taxable income of the LLP, which must be reduced by the amount of income and expenses and the amount of damages paid once a year.
